KiddieCorp is pleased to be providing professional child care services to AIA/ APA families. KiddieCorp is in its fourteenth year of providing high quality services to conventions across the country, including the American Bar Association Annual Meeting and the American Academy of Pediatrics. The KiddieCorp team is composed of bonded, qualified child care specialists, carefully selected and trained. KiddieCorp features custom-designed programs of developmental, educational, and creative activities for each age group, including souvenir arts and crafts projects, toys, games, and entertainment.

Child Care will be located at the San Diego Marriott Hotel and Marina and will be available January 4-6, 2001 (Thursday through Saturday). The cost is \$10.00 per child per hour. This service is parent driven, and is subject to cancellation if the daily minimums are not met. **The deadline for registration is November 30, 2000. The AIA/ APA and KiddieCorp reserve the right to cancel child care due to insufficient pre-registration. Late or on-site reservations will be available on a space-available basis only.** Child care registration cancellations must be made prior to November 30 for a full refund. Cancellations after that time are subject to a 50% cancellation fee.

KiddieCorp provides snacks and beverages, but not lunches. Parents can bring lunch for their children, or arrange for lunch through the hotel. Parents with infants should bring diaper-changing supplies, formula/baby food, and a change of clothes. Please label all personal belongings. KiddieCorp staff does not administer medication. To ensure a safe and fun-filled environment, any child that is ill will not be admitted to the child care center.

KiddieCorp accepts children ages 6 months through 12 years old. Please indicate the time periods you would like for each child.
